ourse Description:

This course will explore the following aspects related to ASEAN community:

- (1) Preparation for ASEAN community in 2015.
- (2) Consideration of three pillars: Political-security community, Economic community, and Socio-cultural community.
- (3) Vision and future of ASEAN Economic Community (AEC).
- (4) Measures for member countries to ease the trades between ASEAN members.
- (5) Preparation for Thai business sectors for the change in free flow of capital and investment, free flow of goods and services, and free flow of human resources.

ASEAN community is of an interest in business management. Understanding the ASEAN community is critical to the success in business in years to come (2015 and beyond). Thus, this course is offered to students in all majors (Accounting, Finance, and Marketing). Each of the three majors will register in the course related to the area of concentration (AC422, FN499, or MK391). The first part of the course will be lecture-based (7-8 sessions) and the second part of the course will be arranged in a form of study trip to ASEAN countries. The students need to explore the business opportunities and determine the associated threats (if any) related to their area of concentration. The end result of this study is the project discussing the effect of ASEAN community on the business management with the in-depth discussion related to area of concentration of each student.

AC422 International Accounting

Prerequisite: Forth-year student

A study of accounting for and international accounting practices. This course provides background for a profound understanding of international financial reporting. International accounting environment factors (such as the accounting profession development) affect the process of setting national accounting standards, accounting practices, and accounting guidance. This course also covers the problem of international transfer pricing, roles and limitations of accounting information system in the financial statements analysis and international business management as well as the related tax issues and the international accounting standards.

FN499 Independent Studies in Finance

Prerequisite: FN 311 and FN 312

The course encourages the students to conduct a research for testable hypothesis in finance under the supervision of the advisor. Students will learn methods for data collection, data analysis, and how to write research paper.

MK391 Special Topics in Marketing I

Prerequisite: Marketing-majored junior or approval from the instructor

A study of recent developments, concepts, and tools in a specific marketing-related area that benefits students' thinking and future career.

Ourse Objectives:

We are realized the globalized world in which we live and about the supposed suffered or alleged benefits of "globalization." For it or against it, the fact remains globalization is here to stay. We also live in a regionalizing world – a number of regional integration schemes have mushroomed in recent years, including ASEAN. What is the process of its "regionalization?" How has this process varied over time and across space? What factors have driven it? How do regionalization and globalization relate? Finally, what sorts of consequences has the process of this regionalization had for qualities of life, standards of living and democratic governance?

This course addresses itself to these questions through a focus on "ASEAN regional integration." It proceeds in two parts. Part I of the course introduces the topic of regional integration, theories of regional integration, and series of ASEAN background knowledge for conceptualized idea of how to managing the business in this regional context. Part II offers unique opportunities to students to participate in the study trips to ASEAN countries (Trip 1 Singapore and Malaysia, and Trip 2 Vietnam) to explore practical experiences from business profession who is in the ASEAN arena, and governing bodies who plays important roles in uniting ASEAN countries in years to come.


